

**BYLAW # 401-25
Village of Amisk
2025 Utility Bylaw**

A By-Law for the Village of Amisk in the Province of Alberta authorizing billing changes for: water, sewer and garbage, commencing February 28, 2025.

Whereas the Municipal Council of the Village of Amisk now duly assembled hereby enacts as follows:

Water	\$50.15 per month for the first 4000 gallons

Water	\$68.15 per month for the first 10,000 gallons
	\$4.00 per 1000 gallons over

HOTELS	
Water	\$57.15 per month for the first 10,000 gallons
	\$4.00 per 1000 gallons over
	\$4.25 per month - capital infrastructure
Sewer	\$30.60 per month
	\$4.25 per month - capital infrastructure
GARDENS	
Water	\$61.50 per 1000 gallons
	\$4.00 per 1000 gallons over
SEASONAL RESIDENTS (minimum of 2 months and maximum 6 months)	
Water	\$25.08 per month \$4.25 per month – capital infrastructure
Sewer	\$8.80 per month \$4.25 per month – capital infrastructure
Garbage	\$13.12 per month

Water Shut-off and Reconnect

- If your water is shut off at the C/C valve you will not be charged a monthly fee for water, sewer and garbage or water and sewer infrastructure. All water reconnects will be charged a fee of \$100.00 at the time of reconnection, excluding garden meters.
- Water meter will be removed at the time of shut off

Penalties

- 2% penalty will be added on any unpaid balance after 60 days.
- Any unpaid balances, 6 months and older will be added to tax roll December 1 of each calendar year and be subject to 15% interest on January 1.

Seasonal Residents

- To receive the seasonal utility rate, a letter of request must be submitted to the CAO at the Village Office, 30 days in advance of vacancy. Request will be presented to council, by CAO, for approval.



This bylaw rescinds any previous bylaws regarding water, sewer and garbage.

Read a first time this 24th day of February, 2025.

Read a second time this 24th day of February, 2025.

Read a third time and finally passed this 24th day of February, 2025.
